

WARRANTY CONDITIONS

LEXAN™ SHEET F2000

FIVE YEAR LIMITED WARRANTY ON BREAKAGE

LEXAN™ F2000 sheet will not break due to loss of impact strength when used indoors within five (5) year of the date of sale by SABIC.

This limited written warranty is subject to the following conditions:

- This limited written warranty applies exclusively to standard uncoated Lexan sheet produced by SABIC in Europe, used correctly as flat curved sheet, formed and handled, stored, processed, installed and maintained according to SABIC recommendations contained in the Technical Manual.
- 2. This limited written warranty does not apply to sheet that has been scratched, abraded or exposed to corrosive materials or chemicals.
- 3. This limited written warranty is given only to the original purchaser of SABIC sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to SABIC the original sales receipt which must contain the name and address of the purchaser, the date of the purchase, the complete product name, the lot number and the volume purchased. On request of SABIC claimant must allow the material to be inspected on site and/or return the sheet to SABIC for testing.
- 4. For the purpose of this limited written warranty: Mechanical properties after 5 year:
 - a. The modulus of elasticity will be ≥ 1700 MPa. The elastic modulus is measured in the tensile test according ISO 527.
 - b. The tensile strength is will be ≥ 55 MPa. The tensile strength is measured in the tensile test according ISO 527.
- 5. SABIC reserves the right to investigate independently the cause of failure.

6. If a claim under this limited written warranty is justified, SABIC will provide the purchaser with replacement material free of charge. accordance with the following schedule:

Time from Orig. Purchase Date	Mechanical failure
Up to 3 year	100%
in 4th year	50%
in 5th year	15%

- 7. This limited written warranty shall be SABIC sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. This limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express of implied, including any warranty of merchantability or fitness of purpose. This warranty shall be governed by the laws of the Netherlands.
- 8. This limited written warranty has been issued on June 23rd, 2022 and is restricted to LEXAN F2000 material sold by SABIC after such date and supersedes all previously issued warranties for LEXAN F2000 sheet, sold after said date. The validity of this limited written warranty is restricted to LEXAN F2000 sheet, and this limited written warranty is the sole warranty for LEXAN F2000 sheet.
